Sub: Important information regarding sales and purchase of Narcotic drugs and Schedule H1 drugs

Dear Sir,

AIOCD is continuously working to safeguard the interests and welfare of all its members. Recently, on August 5th, a notice was issued by the NCB stating that those selling NrX medicines have been registered on their portal.

In response, AIOCD immediately intervened and successfully received a revised circular from the authorities.

As responsible custodians of public health, it remains our duty to strictly avoid any illegal activities in this sector. Please ensure that.

- A. Sales and purchase record of all narcotics and schedule H1 products should well maintained
- B. Schedule H1 registered should be maintain for sale and purchase
- C. Huge quantity of narcotic drugs and ant-depress ace should be done with proper verification and documentation
- D. For sale of huge quantities purchase order on letterhead with proper seal and singed should be demanded
- E. sale of such products should be avoided in cash sale and payment for the same should be accepted through online, cheque or another proper mode
- F. the products marked with "NRx" symbol should be prepared as Narcotic drugs
- G. sale of Ant-cold products containing pseudoephedrine should also sold with proper care on above suggested terms only (for huge quantity) your purchase and sales records are well-maintained, along with the Schedule H1 register, to present to the authorities if needed, as the ongoing surveys by the NCB and FDA may require compliance checks.

Foot note : The principal rules were published in the Official Gazette vide notification No. F.28-10/45-H (1), dated 21st December, 1945 and last amended vide notification number **G.S.R. 72 (E), dated the 8th February, 2013.**

The supply of schedule H1 specified medicines shall be recorded in a separate register at the time of the supply, giving the name and address of the prescriber, the name of the patient, the name of the medicine and the quantity supplied. Such records shall be maintained for three years and be open for inspection.
